ABSTRAK

Penelitian ini membahas mengenai Kerjasama Bilateral Kuba AS pasca normalisasi hubungan kedua negara periode 2014-2017. Normalisasi kedua negara menciptakan dinamika baru terhadap kawasan Amerika dan sekitarnya, melalui berbagai kerjasama Bilateral kedua negara dapat memperlihatkan keharmonisan hubungan yang telah terputus sejak tahun 1960. Penelitian ini berfokus pada pasca normalisasi hubungan kedua negara dalam bidang kerjasama bilateral. Penelitian ini mengangkat pertanyaan penelitian “**Bagaimana Implementasi Kerja Sama Bilateral Kuba-AS Pasca Normalisasi Hubungan Kedua Negara periode 2014-2017**” untuk menjawab pertanyaan tersebut peneliti menggunakan kerangka pikir penelitian ini menggunakan teori Kerjasama Bilateral, Konsep Kepentingan Nasional dan Konsep Normalisasi Hubungan. ABSTRACT

*This study discusses the US Cuban Bilateral Cooperation post-normalization of relations between the two countries from 2014-2017. Normalization of both countries creates new dynamics to the American region and beyond, through various Bilateral cooperation the two countries can show the harmony of relationships that have been interrupted since 1960. This study focuses on post-normalization of relations between the two countries in the field of bilateral cooperation. This research raises the question of "**How is the implementation of Cuban Bilateral cooperation with United States post normalization of relations between the two countries in 2014 to 2017 ?**" to answer that question, the researcher uses the framework of thinking of this research using the theory of Bilateral Cooperation, the Concept of National Interest and the Concept of Relations Normalization.
