

HUBUNGAN KONFLIK PERAN GANDA PERAWAT DENGAN IMPLEMENTASI TEPAT OBAT PADA ERA PANDEMI COVID-19 DI RUANGRAWAT INAP RSUD KOTA BOGOR

Abstrak

Keberhasilan suatu proses pengobatan dipengaruhi oleh implementasi prinsip enam benar yang dilakukan perawat saat memberikan obat kepada pasien. Kesalahan dalam pemberian obat dapat disebabkan karena faktor individu salah satunya kelelahan. Perawat wanita seringkali mengalami konflik peran ganda yaitu kondisi dimana ada gesekan antara pekerjaan dan keluarga yang dapat berakibat negatif pada salah satunya. Hal ini dapat memengaruhi perilaku perawat saat memberikan asuhan keperawatan kepada pasien. Tujuan penelitian ini adalah untuk mengidentifikasi hubungan konflik peran ganda perawat dengan implementasi tepat obat pada era pandemic Covid-19 di Ruang Rawat Inap RSUD Kota Bogor. Metode penelitian menggunakan pendekatan *cross sectional* dengan teknik pengambilan sampel *total sampling* sebanyak 51 orang perawat pelaksana. Hasil penelitian menggunakan uji *chi square* didapatkan ada hubungan yang signifikan antara konflik peran ganda perawat dengan implementasi tepat obat ($p\ value = 0,000$). Rekomendasi penelitian ini adalah tim manajemen rumah sakit senantiasa memerhatikan masalah konflik peran ganda pada perawat wanita seperti memberi dispensasi untuk tidak lembur bekerja.

THE RELATIONSHIP OF WORK FAMILY CONFLICT OF THE NURSE WITH THE RIGHT IMPLEMENTATION OF MEDICINES IN THE COVID-19 PANDEMIC ERA IN HOSPITAL SPACE AREA OF BOGOR GENERAL HOSPITAL

Abstract

The success of a treatment process is influenced by the implementation of the six right principles that nurses do when giving drugs to patients. Errors in drug administration can be caused by individual factors, one of which is fatigue. Female nurses often experience work family conflict, a condition where there is friction between work and family which can have a negative impact on one of them. This can affect the behavior of nurses when providing nursing care to patients. The purpose of this study was to identify the relationship between nurses' dual role conflicts with the proper implementation of drugs in the Covid-19 pandemic era in the hospital space area of Bogor General Hospital. The research method used a cross sectional approach with a total sampling technique of 51 nurses. The results of the study using the chi square test found that there was a significant relationship between the dual role conflict of nurses and the proper implementation of drugs (p value = 0.000). The recommendation of this study is that the hospital management team always pays attention to the problem of dual role conflicts in female nurses, such as giving dispensation not to work overtime.
