

HUBUNGAN SUPERVISI KEPALA RUANGAN DENGAN METODE ELECTRONIC NURSING DOCUMENTATION PADA ERA PANDEMI COVID-19 DI RSUD PASAR MINGGU JAKARTA

Abstrak

Penerapan *electronic nursing documentation* membuat perawat merasa kesulitan untuk beradaptasi dengan sistem tersebut. Dibutuhkan peran kepala ruangan dalam mengatasi masalah ini. Supervisi dilakukan oleh kepala ruangan dapat berpengaruh terhadap kualitas *electronic nursing documentation* yang merupakan pengembangan sistem terkomputerisasi yang telah dibuat oleh rumah sakit dalam pencatatan asuhan keperawatan. Tujuan penelitian ini adalah untuk mengidentifikasi hubungan supervisi kepala ruangan dengan pelaksanaan asuhan keperawatan metode *Electronic Nursing Documentation* pada Era Pandemi Covid-19 di Ruang Rawat Inap RSUD Pasar Minggu Jakarta. Penelitian ini menggunakan desain penelitian deskriptif korelasi dengan menggunakan pendekatan *cross sectional*. Teknik pengambilan sampel yang digunakan adalah *purposive sampling* dengan jumlah sampel sebanyak 129 perawat. Pengumpulan data menggunakan kuesioner dan dianalisis menggunakan uji *Chi-Square*. Hasil uji statistik menunjukkan ada hubungan yang signifikan antara jenis kelamin ($p=0,016$) dan supervisi ($p=0,000$) dengan *electronic nursing documentation*. Tidak ada hubungan antara usia ($p=0,275$), status pernikahan ($p=0,272$), tingkat pendidikan ($p=0,504$), dan masa kerja ($p=0,275$) dengan *electronic nursing documentation*. Kesimpulan dari penelitian ini adalah terdapat hubungan yang signifikan antara supervisi kepala ruangan dengan metode *electronic nursing documentation*. Rekomendasi penelitian ini adalah manajemen rumah sakit diharapkan dapat melakukan supervisi *electronic nursing documentation* secara berkala walaupun dalam kondisi pandemi Covid-19 seperti saat ini.

THE RELATIONSHIP OF SUPERVISION OF THE HEAD ROOM WITH THE ELECTRONIC NURSING DOCUMENTATION METHOD IN THE ERA OF COVID-19 IN PASAR MINGGU HOSPITAL JAKARTA

Abstract

The application of electronic nursing documentation makes it difficult for nurses to adapt to the system. It takes the role of the head of the room in overcoming this problem. Supervision carried out by the head of the room can affect the quality of electronic nursing documentation which is the development of a computerized system that has been made by the hospital in recording nursing care. The purpose of this study was to identify the relationship between the supervision of the head of the room and the implementation of nursing care using the Electronic Nursing Documentation method during the Covid-19 Pandemic Era in the Inpatient Room of Pasar Minggu Hospital, Jakarta. This study uses a descriptive correlation research design using a cross sectional approach. The sampling technique used was purposive sampling with a total sample of 129 nurses. Collecting data using a questionnaire and analyzed using the Chi-Square test. The results of statistical tests showed that there was a significant relationship between gender ($p=0.016$) and supervision ($p=0.000$) with electronic nursing documentation. There was no relationship between age ($p=0.275$), marital status ($p=0.272$), education level ($p=0.504$), and years of service ($p=0.275$) with electronic nursing documentation. The conclusion of this study is that there is a significant relationship between the supervision of the head of the room with the method of electronic nursing documentation. The recommendation of this study is that hospital management is expected to be able to periodically supervise electronic nursing documentation, even in the current state of the Covid-19 pandemic.
