6.2 Saran

Melalui hasil pembahasan dalam penelitian ini sebagai bentuk tindak lanjut dari penelitian penulis memberikan rekomendasi yang bisa dijadikan pertimbangan dalam penelitian selanjutnya yang berkaitan dengan pembahasan serupa.

Amerika Serikat dalam kepemimpinan Donald Trump memang mengambil tindakan yang abai terhadap perubahan iklim, penelitian ini dilandasi oleh kebijakan AFEP dan fokus pada implementasi kebijakan tersebut. Penelitian ini hanya melihat dari sebelah sisi di mana penjabaran implementasi AFEP dan bagaimana isi dari kebijakan tersebut, namun di satu sisi juga terdapat publik Amerika Serikat yang menentang setiap tindakan atau aturan dalam AFEP. Sehingga penulis merekomendasikan penelitian selanjutnya untuk turut melengkapi pembahasan dari sisi yang belum terjangkau dalam penelitian ini. Selanjutnya, Amerika Serikat telah melakukan pemilihan presiden pada 2020 lalu, Joe Biden kini menjadi Presiden baru Amerika Serikat. Karena Biden merupakan Presiden yang berasal dari partai demokrat, penulis juga merekomendasikan untuk meneliti kebijakan energi dan iklim seperti apa yang diambil oleh Presiden yang berasal dari partai demokrat tersebut.

Sedikit saran untuk teman-teman Hubungan Internasional, sebagai mahasiswa HI kita perlu melihat suatu isu, lalu bagaimana negara merespon isu tersebut. Ini bisa dilihat dari kebijakan yang diambil oleh sebuah negara. Penulis menyarankan untuk teman-teman HI agar mengeksplorasi kebijakan sebuah negara terkait suatu isu, karena kita akan menemukan dinamika-dinamika HI yang memiliki ruang untuk di analisis.
