Abstrak

Penelitian ini dilakukan untuk melihat pelaksanaan program keselamatan dan kesehatan kerja dalam proses produksi yang dilaksanakan oleh PT. Top Intera Jaya. Area pabrik tas ini dipilih untuk diteliti karena terdapat 2 kasus kecelakaan, dan penyakit akibat kerja yang pernah terjadi yaitu gangguan pernafasan / asma. Pengumpulan data menghasilkan data primer dengan alat bantu wawancara, observasi dan ceklist. Sample penelitian ini berjumlah 21 pekerja. Hasil penelitian menunjukkan bahwa pelaksanaan program keselamatan dan kesehatan kerja di pabrik tas PT. Top Intera Jaya belum sepenuhnya dilaksanakan dan masih banyak kekurangannya berdasarkan perbandingan dengan penelitian-penelitian terkait. Kesimpulannya yaitu pabrik tas PT. Top Intera Jaya sudah melaksanakan program keselamatan dan kesehatan kerja walaupun belum sepenuhnya dilaksanakan dan masih banyak kekurangannya, maka dari itu sebaiknya perusahaan lebih memperhatikan pelaksanaan program keselamatan dan kesehatan kerja yang belum terlaksana dan mulai melengkapinya satu persatu.
