Saran penulis adalah dengan melihat ulang ketentuan IHR 2005 dan alangkah lebih efektifnya jika direvisikan oleh WHO, melihat ketentuan tersebut dan mengupayakan revisi IHR 2005 seperti amandemen dari IHR 1969 dahulu. Melihat frekuensi munculnya penyakit global yang semakin sering terjadi semenjak tahun 2000-an, menurut penulis status IHR 2005 pada saat ini sudah mendekati batas alami untuk berkembang lebih baik lagi selama bertahun-tahun menghadapi pandemi sebelumnya, untuk mengikuti perubahan penyakit global yang selanjutnya agar lebih siap lagi.
