Jumlah Notaris terus bertambah setiap tahun. Pada awal 2010 Menteri Hukum dan HAM sudah melantik dua ribuan notaris baru yang akan ditempatkan di seluruh Indonesia. Peluang penyebaran Notaris semakin terbuka seiring dinamika pemekaran wilayah. Kini ada 500-an kabupaten/kota di seluruh Indonesia. Namun dalam praktik, formasi Notaris telah menjadi salah satu problem yang mungkin paling memusingkan Kementerian Hukum dan HAM. Formasi Notaris ditetapkan berdasarkan, kegiatan dunia usaha, jumlah penduduk, rata-rata jumlah akta yang dibuat oleh dan atau di hadapan Notaris setiap bulan. Jumlah formasi Notaris berdasarkan kegiatan dunia usaha, ditetapkan dengan kriteria, setiap ada 2 (dua) kantor cabang bank pemerintah atau swasta dapat diangkat minimal 1 (satu) Notaris, setiap ada 3 (tiga) kantor cabang pembantu bank pemerintah atau swasta dapat diangkat minimal 1 (satu) Notaris, setiap ada 3 (tiga) kantor bank perkreditan rakyat dapat diangkat minimal 1 (satu) Notaris, Formasi Notaris berdasarkan jumlah penduduk ditetapkan dengan kriteria, setiap ada 100.000 (seratus ribu) jiwa di Daerah Khusus Ibu Kota Jakarta dapat diangkat minimal 1 (satu) Notaris, setiap ada 50.000 (lima puluh ribu) jiwa di daerah kota dapat diangkat minimal 1 (satu) Notaris, setiap ada 25.000 (dua puluh lima ribu) jiwa di daerah kabupaten dapat diangkat minimal 1 (satu) Notaris, rata-rata jumlah akta yang dibuat oleh dan atau di hadapan Notaris sekurang-kurangnya 50 (lima puluh) akta per bulan. Hambatan dalam penempatan Notaris di wilayah Kota Depok seperti Perguruan Tinggi yang menyelenggarakan pendidikan Notaris hanya berada di kota-kota besar saja, jumlah lulusan dan pilihan penempatan oleh Notaris sendiri yang kurang berimbang, penyebaran Notaris yang kurang merata, Notaris adalah profesi yang profesional tidak mendapat gaji dari pemerintah, jarang Notaris yang mengajukan penempatan di Kota kecil.

But in practice, the formation of the notary has been one of the problems may be the most confusing of the Ministry of Justice and human rights. Notary assigned based on formation, the activity of the business world, the number of inhabitants, the average amount of deed made by or in the presence of a notary public and each month. The number of formations of the notary based on the activities of the corporate world, set criteria, each have 2 (two) Office of Government or private bank branches can be removed for a minimum of one (1) notary public, every three (3) Auxiliary branches of Government or private banks can be removed for a minimum of one (1) notary public, every three (3) Office of the people's bank of the people can be lifted at least one (1) a notary, Notary Formation based on criteria defined by population There, every 100,000 (one hundred thousand) a Special Area in the capital city of Jakarta can be lifted at least 1 (a) every notary, there are 50,000 (fifty thousand) people in the city can be removed for a minimum of one (1) notary public, every there are 25,000 (twenty five thousands) inhabitants in the district can be lifted at least 1 (a) a notary public, the average amount of deed made by or in the presence of a notary public and at least 50 (fifty) certificate per month. Obstacles in the placement of a notary in the city of Depok like College which organizes the Notary education only in big cities. the number of graduates and placement options by a notary who is less balanced, less equitable distribution of Notary, Notary's profession professional gets no salary from the Government, rarely a notary who proposed the placement in the small town.
