Untuk mengetahui bagaimana perjanjian sewa beli (*leasing*) di PT Sun Star Prima Motor Jakarta dilakukan penelitian yuridis normatif. Perjanjian Sewa Beli (*leasing*) menimbulkan akibat hukum bagi para pihak berupa hak dan kewajiban. Perjanjian sewa beli (*leasing*) yang dilakukan oleh para pihak dalam pembelian mobil di PT Sun Star Prima Motor Jakarta telah memenuhi unsur-unsur perjanjian sesuai dengan Pasal 1320 KUH Perdata Indonesia.
