

**PENGARUH PEMBERITAAN TERORISME DI TELEVISI TERHADAP

ABSTRAK

Latar belakang penelitian ini membahas mengenai pengaruh pemberitaan terorisme ditelevisi, reaksi masyarakat ketika kasus terorisme ini muncul sebagai pemberitaan ditelevisi dan dampak yang ditimbulkan akibat terorisme terhadap kewaspadaan masyarakat. **Tujuan Penelitian** adalah untuk mengukur seberapa besar pengaruh dari pemberitaan terorisme di televisi terhadap tingkat kewaspadaan masyarakat. **Tinjauan Pustaka** Komunikasi Massa, Media Massa, Jurnalistik, Efek Media Massa, Pemberitaan, Terorisme, Televisi, Kewaspadaan, Masyarakat. **Metodelogi Penelitian** yang digunakan adalah pendekatan kuantitatif, jenis penelitian eksplanatif dan metode penelitian survei. Populasi penelitian adalah warga RW 08 Kelurahan Cirendeу sebanyak 2280 jiwa dengan sampel penelitian sebanyak 96 responden dihitung menggunakan rumus Yamane. **Hasil Penelitian** uji korelasi, nilai r sebesar 0,814 terdapat hubungan positif yang sangat kuat. Uji regresi, +0,328 yang mempunyai arti bahwa setiap penambahan satu kali untuk pemberitaan terorisme maka tingkat kewaspadaan meningkat sebesar 0,328. Sebaliknya jika negatif pemberitaan terorisme menurun sebesar angka tersebut. Uji T, diperoleh T hitung sebesar 13,58 > Ttable 1,661 artinya Ha diterima Ho ditolak. **Saran** Ini berdasarkan penyataan yang mengatakan bahwa banyak khayal luas yang kurang dalam mencari informasi tentang pencegahan terjadinya terorisme masih kurang dan sudah seharusnya mendapat perhatian dan penayangannya harus lebih diperhatikan oleh media televisi agar khayal luas banyak mendapatkan referensi informasi tentang pencegahan terjadinya terorisme.

ABSTRACT

The background this study deals with the influence of terrorism on television news coverage, the community's reaction when the case is terrorism emerged as the news coverage on television and the impact caused due to terrorism against the vigilance society. The purpose of the research was to gauge the extent of influence of the preaching terrorism on television against the level of vigilance of the public. We Research the quantitative approach is used, the type of research and survey research methods eksplanatif. The population of the research was the citizens RW 08 Village Cirende 2280 and sample as much research as much as 96 respondents were calculated using the formula Yamane. Test results correlation, r value of 0.814 there is a very strong positive relationship. Regression test, + the meaning 0.328 that any addition of a one time for preaching terrorism then the level of kewaspadaaan increased by 0.328. Conversely, if the negative news coverage of terrorism declined by that number. Test T, obtained T count of $13.58 > T$ table 1.661 means Ha Ho accepted rejected. This suggestion is based on the revelation that says much less broad audience seeking information on the prevention of the occurrence of terrorism is still lacking and was supposed to get noticed and it should be taken care of by television media so that a broad audience many get reference information about the prevention of the occurrence of terrorism.
