

KERJASAMA INDONESIA – USAID DALAM MENANGGULANGI TUBERKULOSIS DI INDONESIA 2013-2016

ABSTRAK

Penelitian ini mengkaji mengenai kerjasama antara Indonesia-USAID dalam menanggulangi TB di Indonesia periode 2013-2016. Penyebaran TB di Indonesia mengalami peningkatan setiap tahunnya, sehingga hal ini menyebabkan terbentuknya kerjasama antara Indonesia dan Amerika Serikat melalui organisasi internasional yaitu USAID dalam menanggulangi kasus TB di Indonesia. Penelitian ini mengangkat pertanyaan penelitian **“Bagaimana Implementasi Kerjasama Indonesia-USAID dalam Menanggulangi Tuerkulosi di Indonesia Periode 2013-2016?”**. Untuk dapat menjawab pertanyaan tersebut penulis menggunakan sejumlah teori dan konsep seperti Teori Kerjasama Internasional, Teori Organisasi Internasional, Konsep *Technical Assistance* dan konsep *Human Security*. Metode ini menggunakan metode kualitatif deskriptif, yang menitik beratkan kepada penggunaan data primer yang berasal dari wawancara dan dokumen resmi serta data sekunder lainnya untuk menunjang pembahasan serta pemahaman mengenai penelitian ini. Berdasarkan analisa data yang dilakukan, diperoleh kesimpulan bahwa kerjasama antara indonesia dengan USAID memberikan bantuan dana dan *technical assistance* melalui Program CEPAT (*Community Empowerment of People Against Tuberculosis*) yang bertujuan untuk meningkatkan kesadaran akan upaya pencegahan dan deteksi dini TB, serta menggalang dan memfasilitasi komitmen daerah terhadap program TB nasional, dengan diimplementasikan melalui beberapa kegiatan seperti, *Supply side of health, Health promotion, Management, dan Sustainability*.

ABSTRACT

This study examines the working relationship between Indonesia-USAID in tackling Tuberculosis in Indonesia period 2013-2016. Tuberculosis spread in Indonesia has increased every year, so this has led to the formation of cooperation between Indonesia and the United States through an international institution, USAID, in tackling cases of Tuberculosis in Indonesia. This study raises the question "How Implementation of Indonesia-USAID Cooperation in Tackling Tuberculosis in Indonesia Period 2013-2016?". To be able to answer questions using theories and concepts such as The Theory of International Cooperation, Theory of International Organizations, Concepts of Technical Assistance and Concepts of Human Security. This method uses descriptive qualitative method, which focuses on the use of primary data derived from interviews and official documents and other secondary data to support the discussion and understanding of this research. Based on data analysis conducted, it is concluded that the cooperation between Indonesia and USAID provides funding and technical assistance through Community Empowerment Program of People Against Tuberculosis which aims to increase awareness of prevention and control of Tuberculosis, as well as to prevent and to the national Tuberculosis program , by implementing various activities such as, Health supply side, Health promotion, Management, and Sustainability.
