Abstrak

Interdependensi dan pengabdian terhadap sesama adalah azas sosialitas yang mendasari hubungan dalam masyarakat. Adam Smith menyatakan bahwa manusia adalah faktor produksi utama yang menentukan kemakmuran bangsa. Pembagian kerja dan spesialisasi akan meningkatkan kesejahteraan masyarakat. Pertumbuhan penduduk mengakibatkan masalah pengangguran. Penyerapan tenaga kerja perlu ditingkatkan, termasuk melalui penempatan tenaga kerja di luar negeri. Tenaga kerja Indonesia di luar negeri memberikan kontribusi ekonomi dan solusi untuk pengangguran. Namun, terdapat masalah pelanggaran hak dan eksplorasi terhadap pekerja migran. Perjanjian IA-CEPA antara Indonesia dan Australia bertujuan memperkuat kerja sama ekonomi. Meskipun memiliki potensi manfaat, permasalahan hak pekerja migran dan perbedaan budaya masih menjadi tantangan. Pentingnya kerja sama bilateral untuk melindungi hak pekerja migran. Pengaruh IA-CEPA terhadap perlindungan hak-hak pekerja migran Indonesia di Australia perlu diteliti lebih lanjut.

Abstract

Interdependence and dedication to others are the principles of sociality that underlie relationships within society. Adam Smith stated that humans are the main production factor determining a nation's prosperity. Division of labor and specialization contribute to the well-being of society. Population growth leads to unemployment issues. Increasing workforce absorption is necessary, including through placing workers abroad. Indonesian workers overseas contribute economically and offer solutions to unemployment. However, issues of rights violations and exploitation of migrant workers exist. The Indonesia-Australia Comprehensive Economic Partnership Agreement (IA-CEPA) aims to strengthen economic cooperation. Despite potential benefits, challenges regarding migrant worker rights and cultural differences remain. Bilateral cooperation is crucial to safeguard migrant worker rights. The impact of IA-CEPA on the protection of Indonesian migrant worker rights in Australia requires further research.
