

ABSTRAK

AKUNTABILITAS PENGAWASAN PELAKSANAAN *RESTORATIVE JUSTICE* DI SALAH SATU KEPOLISIAN SEKTOR DI JAKARTA TIMUR

Penelitian ini bertujuan untuk menganalisis akuntabilitas pengawasan pelaksanaan restorative justice di salah satu Kepolisian Sektor di Jakarta Timur. Restorative justice adalah pendekatan penyelesaian kasus pidana yang menekankan pemulihan hubungan antara pelaku, korban, dan masyarakat, serta mengutamakan kesepakatan damai. Penelitian ini mengkaji mekanisme pelaksanaan restorative justice, termasuk proses mediasi, kompensasi hak korban, serta tantangan yang dihadapi dalam implementasinya. Metode penelitian yang digunakan adalah yuridis empiris dengan pendekatan deskriptif analitis. Data dikumpulkan melalui wawancara dengan penyidik, observasi langsung, dan studi dokumen terkait pelaksanaan restorative justice di salah satu Kepolisian Sektor di Jakarta Timur. Hasil penelitian menunjukkan bahwa meskipun mekanisme restorative justice telah diterapkan dengan baik, terdapat kelemahan dalam sistem pengawasan yang ada, terutama terkait dengan kurangnya transparansi dan akses informasi publik. Penelitian ini merekomendasikan peningkatan kapasitas petugas melalui pelatihan, pengembangan sistem pelaporan yang transparan, serta evaluasi berkelanjutan terhadap pelaksanaan restorative justice. Dengan menerapkan saran-saran tersebut, diharapkan salah satu Kepolisian Sektor di Jakarta Timur dapat meningkatkan akuntabilitas dan efektivitas pelaksanaan restorative justice serta membangun kepercayaan masyarakat terhadap institusi kepolisian.

ABSTRACT

ACCOUNTABILITY OF SUPERVISION IN THE IMPLEMENTATION OF RESTORATIVE JUSTICE AT ONE OF THE POLICE SECTOR UNITS IN EAST JAKARTA

This research aims to analyze the accountability of monitoring the implementation of restorative justice in one of the Police Sectors in East Jakarta. Restorative justice is an approach to resolving criminal cases that emphasizes restoring relationships between perpetrators, victims, and the community, and prioritizes peaceful agreements. This research examines the mechanisms of implementing restorative justice, including mediation processes, compensation for victims' rights, and challenges faced in its implementation. The research method used is juridical empirical with a descriptive analytical approach. Data was collected through interviews with investigators, direct observation, and document studies related to the implementation of restorative justice in one of the Police Sectors in East Jakarta. The results show that although the restorative justice mechanism has been well implemented, there are weaknesses in the existing monitoring system, particularly regarding the lack of transparency and public access to information. This research recommends increasing officer capacity through training, developing a transparent reporting system, and conducting continuous evaluation of restorative justice implementation. By implementing these suggestions, it is expected that one of the Police Sectors in East Jakarta can improve the accountability and effectiveness of restorative justice implementation and build public trust in the police institution.
