

TINJAUAN ATAS *CASH CALL* DAN *JOINT INTEREST BILLING (JIB)* PADA BADAN OPERASI BERSAMA PT BUMI SIAK PUSAKO – PERTAMINA HULU

ABSTRAK

Tugas Akhir ini membahas tentang tinjauan atas *cash call* dan *Joint Interest Billing (JIB)* pada Badan Operasi Bersama PT Bumi Siak Pusako - Pertamina Hulu. BOB PT Bumi Siak Pusako-Pertamina Hulu merupakan salah satu bentuk operasi bersama “*Joint Operation*” antara Pemerintah Pusat yang diwakili oleh Pertamina Hulu dan PT Bumi Siak Pusako selaku wakil dari Pemerintah Daerah dengan kontraktor migas Indonesia. *Joint operation* menghasilkan 2 (dua) Kontrak Kerja Sama (KKS) atau *Joint Operation Contracts* yaitu *Production Sharing Contract (PSC)* dan *Joint Operation Agreement*. *Production Sharing Contract (PSC)* merupakan perjanjian antara kontraktor migas dengan Pemerintah Indonesia. Sedangkan, *Joint Operation Agreement (JOA)* merupakan perjanjian antara kontraktor migas dengan industri minyak dan gas hulu. Sumber dana utama dalam pembiayaan operasi dan aktivitas perminyakan adalah *cash call* yang berasal dari PT Bumi Siak Pusako dan Pertamina Hulu selaku *partner*. BOB sebagai operator dari kegiatan minyak hulu berkewajiban untuk membuat laporan terkait perkembangan dari operasi perminyakan dan pertanggungjawaban atas dana *cash call* kepada *partner*, berupa *Joint Interest Billing (JIB)*. *Joint Interest Billing (JIB)* terdiri dari 4 laporan yaitu; *lifting summary*, *share calculation*, *work program and budget realization*, dan *cost recovery*.

ABSTRACT

This Final Project tells about the observation of cash call and Joint Interest Billing (JIB) in the joint operating body (JOB) of PT Bumi Siak Pusako – Pertamina Hulu. JOB Of PT Bumi Siak Pusako Pertamina Hulu is one from of Joint Operation (JO) between central government is represented by Pertamina Hulu and PT Bumi Siak Pusako as a deputy from regional government with oil and gas contractor in Indonesia. Joint Operation (JO) produces 2 (two) Joint Operation Contract (JOC) is Production Sharing Contract (PSC) and Joint Operation Agreement (JOA). Production Sharing Contract (PSC) is agreement between oil and gas contractor with Indonesian's government. While, Joint Operation Agreement (JOA) is agreement between oil and gas contractor with oil and gas industry hulu. The main funding source for financing operations and petroleum activities is a cash call from PT Siak Pusaka and Pertamina Hulu as a partner. JOB PT Bumi Siak Pusako – Pertamina Hulu is an operator from upstream oil activities obliged to make reports related to developments from the oil operations and accountability for cash call funds to partners, Joint Interest Billing (JIB) form. Joint Interest Billing (JIB) consists of 4 (four) reports: Lifting Summary, Share Calculation, Work Program and Budget Realization, and Cost Recovery.
