Abstrak

Praktik Kerja Lapangan dilakukan selama 3 bulan terhitung mulai 16 Desember s.d. 13 Maret pada Badan Penyuluhan dan Pengembangan SDM Pertanian (BPPSDMP) Kementerian Pertanian RI. Dalam pelaksanaan kegiatan praktik diposisikan di Subbagian Akuntansi dan Verifikasi untuk membantu melakukan verifikasi dan menyusun laporan keuangan. Kendala yang dihadapi dalam Praktik Kerja Lapangan masih kurangnya pengalaman tentang proses verifikasi berbagai dokumen sumber pendukung, alur proses verifikasi, pembuatan nota verifikasi, dan proses penyusunan Laporan Keuangan. Laporan Keuangan yang disusun yaitu Laporan Keuangan Semester I 2019 berupa Laporan Realisasi Anggaran, Neraca, Laporan Operasional, Laporan Perubahan Ekuitas, dan Catatan atas Laporan Keuangan (CaLK) dan mengacu Peraturan Pemerintah Nomor 71 Tahun 2010 tentang Standar Akuntansi Pemerintah dan kaidah-kaidah pengelolaan keuangan yang sehat dalam pemerintahan. Abctract

The Field Work Practice (PKL) activity aims to apply the knowledge that has been obtained from semester 1 until semester 5 and to increase the knowledge and science obtained in the agency where the street vendor is. Fieldwork practices are conducted for 3 month starting December 16 until march 13 2020 at the Agricultural Human Resources Development and Counseling Agency (BPPSDMP) of the Indonesian Ministry of Agriculture.
