KERJA SAMA *CAPACITY BUILDING* ANTARA BADAN NARKOTIKA NASIONAL REPUBLIK INDONESIA – *AUSTRALIAN FEDERAL POLICE*

Narkotika merupakan kejahatan yang sudah ada sejak dahulu sampai sekarang. Narkotika tidak mengenal usia, semua golongan usia bisa terkena. Sehingga dalam era globalisasi ini, sangatlah mudah seseorang menjadi target dalam penyelundupan atau pemakaian narkotika ini. Tahun 2011, Badan Narkotika Nasional Republik Indonesia (BNN RI) dan *Australian Federal Police* (AFP) menjalin kerja sama dalam rangka pemberantasan penyelundupan perdagangan gelap narkotika. Upaya tersebut dilakukan untuk melawan kejahatan narkotika. Dengan berkembangnya motif dan modus kejahatan narkotika, perlu sebuah inovasi pengembangan kapasitas yang dilakukan AFP terhadap BNN RI.

Penelitian ini bertujuan untuk menggambarkan proses dan implementasi apa saja yang sudah dilakukan dalam kerja sama antara BNN RI dan AFP. Peneliti menggunakan pendekatan Liberalisme klasik dengan metode Interdependensi dalam melihat kerja sama di antara kedua instansi tersebut. Peneliti juga menggunakan konsep narkotika sebagai kejahatan transnasional, sebagai topik utama dan juga untuk melihat tingkat bahaya dari narkotika. Peneliti menggunakan konsep *capacity building*, di mana untuk melihat dimensi kerja sama yang dilakukan kedua instansi tersebut. Peneliti juga menggunakan konsep MoU dalam mengetahui dan alat untuk *me-review* MoU kerja sama BNN RI dan AFP.

Penggunaan metode penelitian kualitatif dengan pendekatan deskriptif dipilih oleh peneliti untuk dapat mendeskripsikan bagaimana proses kerja sama dan implementasi kerja sama pengembangan kapasitas dalam kerangka kerja sama BNN RI dan AFP. Hasil penelitian ini menunjukkan adanya implementasi pengembangan kapasitas di bidang *canine* (K-9), bidang intelijen, dan pengembangan personal di bidang Bahasa serta kepemimpinan.
